## Terms & conditions of participation in the

### “2<sup>nd</sup> CHANCE DRAW” & “SPECIAL EVENT”

Scope of the Contest: The Société Anonyme under name “Hellenic Lotteries S.A.”, having its seat in Athens (112 Athinon Ave.), TIN 800500383, Athens Taxation of Commercial S.A. Alternatively, the player, through a mobile device, may scan the data matrix code that appears in “Scratch here and scan in OPAP STORE APP” field, through the application OPAP Store App. Then, provided that they select the relevant promotional indication of the “2<sup>nd</sup> Chance” (banner), they are redirected to website [www.scratch.gr](http://www.scratch.gr) and they successfully complete their registration in “2<sup>nd</sup> Chance” section, then they may enter (or scan through the relevant QR code) the seven-digit 2<sup>nd</sup> Chance unique code which is mentioned on the front side of the ticket, in the specific “2<sup>nd</sup> Chance” area. In the first draw machine, as many balls as needed to cover the number of millions or of hundred thousands or of ten thousands. For example, if the total number of entries is 4,120,589 or 454,679 or 45,832, then the balls featuring numbers 0 to 4 shall be placed in the first draw machine.

In each one of the rest draw machines to be used, ten (10) balls shall be placed, featuring numbers 0 to 9.

Then, all draw machines shall be set in motion at the same time to stir the balls inside them, and the first number will be drawn through an automatic process.
